Retirees and Qualified Charitable Distributions

Did you know if you are 70 ½ or older, you can have a check sent from your IRA directly to Rainbows United and never pay federal or state income taxes on those dollars? Using the Qualified Charitable Deduction, or QCD can benefit both you and Rainbows United. Contact your IRA administrator to ask for their process to write a check to Rainbows out of your account. It's usually an easy form, sometimes online.

For those age 72 and up, the QCD can also be used as part or all your Required Minimum Distribution (RMD) to

reduce your taxable income.

The key QCD provisions include: 1) You must be at least 70 ½ at the time of the gift; 2) The gift must be received by the nonprofit by December 31st; 3) The gift must be sent directly by the IRA administrator to the nonprofit; and 4) The annual QCD maximum is \$100,000.

Be sure to talk to your financial planner today about how QCD can work for your charitable giving. Rainbows is not engaged in rendering legal or tax advice. Legal counsel or advice from a certified financial planner should be sought when considering giving options.

Early Intervention Services provided in Butler, Sedgwick and Sumner Counties

Rainbows serves nearly 2,000 children annually through Infant/ Toddler Services. Many children have been helped in Butler and Sedgwick Counties for years; now Rainbows United, Inc. has added Infant/Toddler Services to children birth to age three in Sumner County.

Services begin with a free developmental evaluation. When a child qualifies for any of the mandated services they are provided in the family home at no cost to the family. Services depend on specific needs.
