In Fiscal Year 2019 Rainbows celebrated 47 years of making a difference in the lives of children and their families. More than **3,880 children with special needs**, birth through age 21 and their families were served through one of our 9 programs.

Staff continued work on **Rainbows' Strategic Plan**. More than half of the items have had action or have been completed. One of the items was soliciting feedback from our employees through the "Voice of the Employee" survey. From this survey 6 focus areas were identified and are being addressed.

Because of the dedicated work of a group of employees, a **new client tracking system**, myEvolv went live on May 6, 2019. We hired Gay Kimble as our new Vice President of Human Resources.

We had more than **721 volunteers put in 9,060 hours of service**. Volunteers are critical in completing many landscaping and facility tasks as well as working with our children and youth.

We look forward to the year ahead and the opportunities to better serve our children/youth and their families. Cheers to 2020!

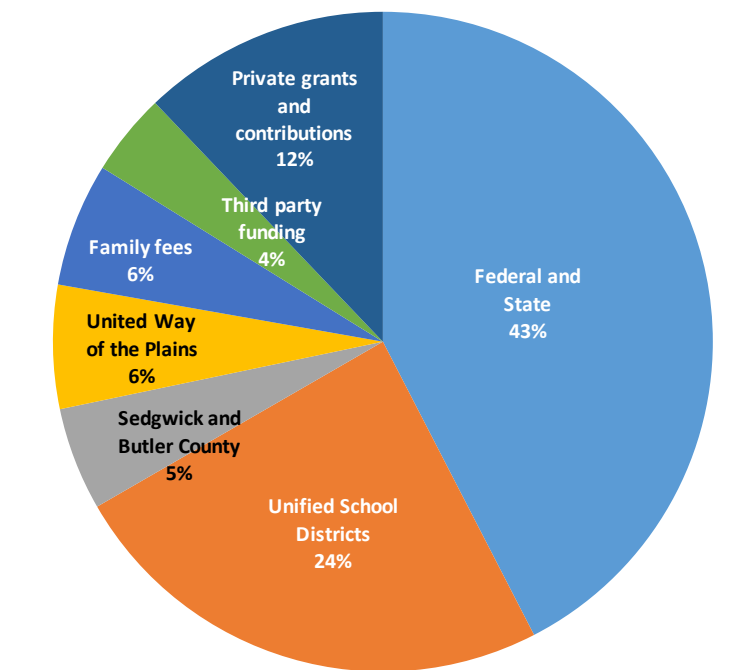
