The 2022 Legislative Session is nearing its end. Legislators will convene in Topeka on April 25 in what is called the "Veto Session". While they still have several

major policy issues to address, Legislators did take action already on our two legislative initiatives: 1) Funding increase for Infant/Toddler services "tiny-k", and 2) Rate increase for the Home and Community Based Services Medicaid Waiver for Individuals with Intellectual/Developmental Disabilities (HCBS – I/DD). That last one is a mouthful, I know. Let me explain more.

Legislators put an additional \$2 million into *tiny-k* services for children birth to age 3 with special

needs. Rainbows provides these services in Butler, Sedgwick, and Sumner Counties. The increase will help all of the 30 *tiny-k* networks who provide services across Kansas.

In addition, Legislators added a historical 25% increase for HCBS Medicaid Waiver rates for individuals with I/DD. This increase will help providers across the State who are struggling to hire staff to care for these vulnerable individuals. For Rainbows, this means a 25% rate increase for our Family Support Services. It is through this program that Direct Support Professionals (DSPs) provide In-Home care for school age children and youth who have developmental disabilities.

This increase of over \$3/hour for these services will go directly to the wages of DSPs in our Family Support

Services.

Rainbows is thrilled to receive this additional support and to be able to pass the increase funding onto our staff who provide these critical services for children and their families.

This Budget was passed by Legislators and Governor Kelly on April 20.



Rainbows helps family navigate Autism



The day before Thanksgiving 2018, 18-month-old Khamoi was diagnosed with Autism. Michael Tatro, Speech/Language Pathologist, was there to support the family in learning about the diagnosis. "Michael literally saved our family," said Rickeyia. "She helped us navigate the whole system and guide us through appointments, and then she helped explain the mind-blowing diagnosis."

"When Khamoi was diagnosed, I was so mad and embarrassed," said Rickeyia. "I cried on the Zoom call with Michael. She made me feel like a person with feelings, not just a Mom. Rainbows helped me recognize these raw feelings of fear, that I was mad at the diagnosis and embarrassed as a parent. These things aren't talked about enough. With Michael's help, I was able to re-think my picture of Khamoi's life."

Khamoi's father, Aikeem was relieved and grateful. "We have a diagnosis," he said. "We're so lucky we caught it so early because of Rainbows. The Autism is hers, but it's also ours as a family. We all hold that diagnosis."
